The terms of reference for State Level Managing Board, Fish Farmers Development Agency is as under :-

1. Duration of terms of the Board :- 2 years from date of formation.
2. Duties and responsibilities :-

(i) Approval of recommended programmes by the District Level Managing Board (DLMB) forwarded to the State Level Managing Board (SLMB) by respective Chief Executive Officers as per guidelines of Fish Farmers Development Agency for submission of proposal to the Govt. of India.

(ii) Allocation of physical and financial targets to various Fish Farmers Development Agency units.

(iii) Final selection of beneficiaries in line with beneficiaries list recommended by the District Level Managing Board.

(iv) State Level Monitoring of the programmes basing on the report of the District Level Managing Board and approval of final evaluation report for submission to the Govt. of India.

- (v) The State Level Managing Board should have at least 3(three) sittings in each financial year
- (a) For approving the activities proposed by various District Level Managing Board for submission of proposal to the Govt. of India and allocation of physical and financial targets to various Fish Farmers Development Agency.

 - (c) Review of monitoring and evaluation report submitted by various District Level Managing Board for preparation of state level evaluation report for submission to the Govt, of India


